Key Features

It leverages rich media functions, supporting incorporation and annotation of body diagrams and drawings, as well as signing documents electronically.
- Launch Pad: Allows physicians to review all patient information as well as sign off on orders and results "on-the-go" from anywhere at any time.
- **Clinical Documentation:** Effectively document all assessments and notes including History & Physical (H&P), Review of Systems, Admission, Progress, Transfer and Discharge notes as well as Continuity of Care documents in a user-friendly, intuitive application.
- **Physician Inbox:** Physician Inbox across patients contains new information on which the physicians need to make informed clinical decisions, optimizing the use of their time by providing crucial alerts. The Inbox provides a physician with a to-do list of information that has not been reviewed for the patient (e.g. orders, results and reports) for all assigned patients. The physician can view summary information or drill-down to view more detailed patient data. The following information is available in the Inbox: Critical items to review; Results to review; Orders to sign, review or renew; Results to complete; Results to Sign; and Deficiencies and delinquencies to review.
- Problem List: Provides an at-a-glance overview of the status of a patient's current and historical problems. Physicians can add codified problems, filter the list, review and edit patient problems. Order Entry and Note Documentation is facilitated directly from the Problem List resulting in a streamlined workflow for the clinician. It supports initiating, monitoring, evolving and managing patient problems/diagnoses. The application fosters inter-professional collaborative documentation. Harris Flex' Problem List provides a dashboard overview of the status of a patient's current and historical problems. Physicians, nurses, and allied health professionals (including dietician, physiotherapy, occupational health, respiratory therapy, social worker, and/or rehabilitation staff) can add codified problems, filter the list, review and edit patient problems. While the application is patient-specific, all providers can contribute to a single summary of patient problems. Based on securities, a provider will be able to edit the items relevant to their clinical practice while being able to view documentation by other health professionals. Order entry and documentation is facilitated directly from the Problem List resulting in a most effective workflow for the clinician by linking problems to orders and clinical notes.
- **Chart Review:** Provides a highly configurable, secure, fully integrated, patient-centric data review workflow for the physician. It allows the organization of data based on multiple episodes of care, including ED, clinic and other patient visit types. It allows for rapid retrieval of patient record and access to centralized reporting of statistics for meeting departmental and organizational objectives.


